Call to Order: Commissioner Player called the meeting to order at 5:04 p.m.

Invocation: Commissioner DeLacey led everyone in the invocation.

**Pledge of Allegiance:** Commissioner Player led everyone in the Pledge of Allegiance.

<u>Setting of Agenda:</u> Commissioner Hernandez moved to approve the agenda as presented. Motion seconded by Commissioner Cammick. Motion passed unanimously.

## Public hearing to consider and adopt a Final Millage Rate and Final Budget:

### Hear public comment before any vote.

- Power Point presentation on Final Millage Rate and Final Budget:
  The Power Point was presented by Finance Manager Miles. Initial discussion as per
  Florida Law was the announcement of the proposed millage rate, voted on at the July
  2024 board meeting. The proposed millage rate is 3.7500 mills, which is 4.17% above the
  roll back rate of 3.5998 mills and is therefore considered a tax increase. There were no
  questions from the board regarding the Budget as presented.
- Public comment on Fianl Millage Rate: None
  - Adopt Tentative Millage Rate: **Resolution 2024-011**Commissioner DeLacey commented that although we have set the tentative millage at 3.75, that was with the understanding that we could lower it at this meeting. She has had a discussion with an older gentleman in her neighborhood that was concerned about the increasing taxes and wanted to open the discussion to the idea of a decrease. The commissioners asked what kind of difference the roll back rate would make to the budget and average household. Finance manager Miles explained that it would be a \$322k decrease in income to the district and less than a \$50 difference to a homeowner with \$250k taxable value. Commissioner Hernandez and Cammick disagree with lowering the millage. Given the significant reduction in taxable value we have received since Hurricane Ian it does not seem wise to pull from our reserves to give a slight break at this time.

Commissioner Player read the resolution in its entirety, including 3.7500 mills, which is 4.17% above the rolled-back rate of 3.5998 mills.
